PART TWO : SUMMARY OF THE PROJECT IMPLEMENTATION.

1. If necessary, describe the Specific objectives and the Intermediate results of the project, as mentioned in the project document, as well as the implemented changes (when, how and why).

1.1 General Objective

The general objective, as defined by the identification report, is "The sanitary and hygienic living conditions for the population of Tuy Hoa and the protection of the surrounding environment improved."

1.2 Specific Objective

The specific objective as defined in the identification report is "A better and more selective way of solid waste collection and disposal and awareness raising within these fields implemented." This will no doubt do much to improve the hygienic and sanitary conditions in Tuy Hoa as well as improve the protection of the environment.

1.3. Summary of the intervention

The Project aims to set up a better and more selective way of solid waste collection and processing, and to increase awareness-raising within these fields. To achieve this, a solid waste management plan will be drafted and a modern landfill constructed. At the same time the project will raise public awareness and ask the public to share responsibility regarding the use of collection points and keeping the streets, alleys, and beach clear from rubbish.

2. To which extent was the specific objective of the project reached, according to the accepted indicators?

The project worked with a Project Steering Committee (PSC) meeting every 6 months. The PSC was chaired by the Province of Phu Yen and the BTC.

The PSC proposed to organize a Mid Term Review as well as a Final Evaluation. Both consultancies were implemented and followed up.

PART THREE : COMMENTS AND ANALYSIS.

1. What are the <u>major</u> problems and questions having influenced the project implementation and how did the project attempt to solve them?

We refer to the Final Evaluation consultancy carried out by AF-Colenco consultants Mr. John Gildea and Mrs. Le Thi Huong.

The National Project Director and the Technical Adviser subscribe the evaluation and its recommendations.

Major problems occurring during implementation were:

- Technical design of the sanitary landfill, carried out by a Belgian consultant without Vietnamese technical and legal backup; this caused delays in getting approvals;
- Use of innovative materials (High Density Polyethylene membrane) for the sanitary landfill; it was difficult to find experienced professional welders for this material needing extra time for capacity building;
- Vietnamese legal system and local (provincial) decisions that were not supported by the legal adviser hired by BTC to advise on the main tenders; this also includes delayed approvals from DOC and from DONRE regarding the sanitary landfill;

2. Which factors explain the differences in relation to the awaited results?

We refer to the Final Evaluation consultancy carried out by AF-Colenco consultants Mr. John Gildea and Mrs. Le Thi Huong.

The National Project Director and the Technical Adviser subscribe the evaluation and its recommendations.

Differences are mainly in a positive way. The extra budget added early on in the project allowed to answer to a shift in national and international ways to treat and manage solid waste, focusing on 4R policies: reduce, reuse, recycle, revalue. It allowed to construct a waste sorting, plastic recycling and composting facility.

Less costly but for the project and beneficiaries very important was the focus on the scavengers' activities and grouping them in the scavengers' association.

3. Which lessons can we learn from the project experience? Please give a detailed answer on the impact and the durability of the results.


